## ADMISSION NOTICE -2024-25

**Attention: All Students, seeking admission to LL.B 2<sup>nd</sup>/3<sup>rd</sup> year.**

1. Students of 1<sup>st</sup>/2<sup>nd</sup> year (Academic Session 2023-24), who have not been detained, are being *provisionally promoted* to 2<sup>nd</sup>/3<sup>rd</sup> year respectively. However, all the provisionally promoted students are permitted to attend the classes in the promoted year.

2. All the students of 1<sup>st</sup> year and 2<sup>nd</sup> year who have already cleared 5/15 papers respectively and have not been detained in II/IV term, are eligible for admission to LL.B. 2<sup>nd</sup> /3<sup>rd</sup> Year respectively during the Academic Session 2024-25. Students are hereby advised to submit their Admission Form (available on the LC-I website) in the Law Centre-I office along with the following documents latest by 9<sup>th</sup> August, 2024:-

- i. Self-attested photocopies of all the marks-sheets.
- ii. Photocopy of college ID card (previous year 2023-24).
- iii. Fee receipt.


It may be ensured that all the columns of the Admission Form are duly filled, as incomplete forms cause an unnecessary delay in the admission process. No portion of the Form should be left blank or incomplete.

Duly filled admission form must be submitted along with fee receipt otherwise admission form will not be accepted. Admission fee can be paid through following link: <https://fee.du.ac.in/index.php/site/login> from the Institutional ID only. The amount of Fee would be as follows: Rs.6580/- and for PwD 1645/-

3. Those students who have not cleared 5/15 papers are required to submit a provisional promotion undertaking (available on the LC-I website) latest by 9<sup>th</sup> August, 2024:-Students are advised to fill the same subject option(s) in Admission Form as were filled by them in the Google form circulated earlier. In case of any discrepancies between the two, the Google form option shall prevail.

Please come to relevant windows only between 3.00 p.m. to 6.00 p.m. and refrain from entering the office for submitting your Admission Form and queries related thereto.

- Those students who could not pass in LB-501 (Moot Court Exercise and Internship) paper in the earlier semester are required to submit an application in the LC-I office, General Section (Old Building) to the same effect.
