**Campus Placement at National Commission for Women**

This is to inform the students that National Commission for Women, a statutory body with matters relating to constitutional and legal safeguards provided to women, is inviting to engage legal professionals from the pass out Batch of (2019-2022) and (2020-2023) as Junior Technical Experts (Legal).

**Duration:** Contract basis initially for a period of 1 year.

**Remuneration:** Rs 4.8 lakh per annum.

**Application Process-**

- A written test will be conducted on 10<sup>th</sup> August 2023 at 2 PM and the duration of the same will be 2 hours.
- The test will include questions from the Constitution of India, various legislations related to women's rights, legal terms, and some recent issues pertaining to the protection of women.
- The written test will be descriptive and will comprise an essay, drafting of letters, and short-notes based questions.
- Two officials from NCW would visit our Campus on 10<sup>th</sup> August 2023 for conducting the said Exam.
- All communication regarding this examination shall take place through LC II website.
- The candidates who qualify in the Written Exam will be subsequently called to the office of NCW at New Delhi for an interview.
- All the candidates are required to **submit their details in the enclosed Proforma with their latest Passport size photograph** and submit the same to the team from NCW at the time of Written Exam.
